

## 15<sup>th</sup> International Singing Competition for Baroque Opera

Pietro Antonio Cesti 2024

Innsbruck Festival of Early Music

25. – 30.08.2024

### Rules

#### General information

- Art. 1:** The Innsbruck Festival of Early Music (hereinafter referred to as "Innsbruck Festival") is hosting the International Singing Competition for Baroque Opera Pietro Antonio Cesti for the fifteenth time 25. – 30.08.2024.
- Art. 2:** The objective of the competition is to promote the singing of baroque operas.
- Art. 3:** Irrespective of their nationality, women and men born in 1991 or later, are entitled to participate.
- Art. 4:** By registering to participate in this competition, the competitors promise to comply with the rules of the competition and the performance rules, and to accept the decisions taken by the jury. The participants further promise that they are completely relieved of all professional duties for the duration of the competition.
- Art. 5:** The cast for the Barockoper:Jung 2025 will be made up of the winners of the competition (special prizes). By registering for the competition, all participants commit themselves to be available for this production between 01.07. and 31.08.2025. The Barockoper:Jung production will be remunerated separately. Participants selected as cast members for the Barockoper:Jung will be notified by 31.10.2024 at the latest.

#### Registration

- Art. 6:** Applicants must register by 31.05.2024 at the latest using the online application form including enclosures and an audio recording (mp3/mp4) for the preliminary selection. The registration form and its enclosures plus any other documents mentioned in the rules must be received by the competition committee by the quoted date at the latest. Late or incomplete applications will not be accepted. The application is considered complete only when the application fee has been paid. (see Art.11)
- Art. 7:** Should it be necessary to limit the number of participants, a preliminary selection is carried out by a panel elected by the competition committee based on the documents and recordings submitted. The participants admitted to the competition receive written confirmation of participation by email by 21.06.2024 at the latest.
- Art. 8:** Changes in the registered competition program and the order of the participants' arias are possible until 31.07.2024.

**Art. 9:** The participants admitted to the competition must register at the Haus der Musik Innsbruck (Universitätsstraße 1, Entrance East, 6020 Innsbruck) on 25.08.2024 between 09.00 a.m. and 2.00 p.m., and present their passport or other valid means of identification. Those admitted competitors who do not register at the Innsbruck Festival on time will only be allowed to compete in exceptional cases and with the authorization of the competition committee.

**Art. 10:** Registration papers will not be returned to sender.

**Art. 11:** The registration fee for 2024 is €50.00 to register for the competition and a further €70.00 for participating in the competition from the 1st round. The registration fee of €50.00 must be paid via the registration platform by 31.05.2024 at the latest. The participation fee of €70.00 from the first round is to be paid in cash during the registration procedure for the Innsbruck Festival between 09.00 a.m. and 2.00 p.m. on 25.08.2024 in the Haus der Musik Innsbruck (Universitätsstraße 1, Entrance East, 6020 Innsbruck).

The registration fee cannot be refunded in the event of the participant being prevented from attending.

**Art. 12:** It is possible for competitors to be accompanied by their own répétiteurs. Should the competitor request one, the Innsbruck Festival can provide a répétiteur.

The use of the harpsichords for rehearsal purposes and the time spent with a répétiteur provided by the Innsbruck Festival are limited to 10 minutes in the first and 20 minutes in the second round, per participant. A schedule will be announced following the draw. The allocated slots must be complied with. Participants who do not obey these determined rules can be disqualified from the competition.

If the participant brings his or her own répétiteur he/she will be allowed to rehearse 10 minutes in the first and 20 minutes in the second round, like every other participant with an electrical harpsichord. It is not allowed to rehearse in the competition hall. However, the répétiteur who was brought by the participant is allowed to warm up on the harpsichord in the competition hall alone without participants (by agreement with the competition office). Other rehearsal rooms with pianos are open all day during the competition.

## Draw

**Art. 13:** All participants must be present in person for the draw to be held at 02.30 p.m. on 25.08.2024 in the Haus der Musik in Innsbruck.

The sequence of performances for the first round is determined by drawing lots as follows: in the presence of all others, the youngest participant will draw the name of one participant. This participant will perform first in the first round. The other participants follow according to the order of the German alphabet, starting with the name of the first participant.

The sequence of performances for the second round is determined by drawing lots once more, according to the same process as for the first round. In the presence of all others, the youngest participant of the second round will draw the ticket of one participant.

The sequence of performances for the final is determined by the promoter, the Innsbruck Festival, of the final concert.

## Program & performance rules

**Art. 14:** The singer enters on the registration form the program he or she is contemplating performing as well as the order of the arias. The Innsbruck Festival is to be notified of any changes to the program made at a later date. No further changes may be made after 31.07.2024 not even the order of the arias.

**Art. 15:** The competition program comprises five arias or solo scenes. Should arias be preceded or followed by a solo recitative, it should also be sung.

Three arias/scenes from operas by the following composers are to be prepared for the first two rounds:

- a = hz 440 Bach-Lehmann: Claudio Monteverdi, Pietro Antonio Cesti, Francesco Cavalli, Antonio Sartorio, Giovanni Legrenzi
- a = hz 415 Vallotti: Henry Purcell, Antonio Vivaldi, Johann Adolph Hasse, Georg Friedrich Händel, Georg Philipp Telemann, Giovanni Battista Pergolesi, Nicola Antonio Porpora, Antonio Caldara, Leonardo Vinci, Alessandro Scarlatti, Giovanni Buononcini, Francesco Gasparini, Antonio Lotti, Tomaso Albinoni

The arias for the first two rounds are to be selected in such a way that the performance time does not exceed five minutes in the first round and ten minutes in the second round. The pieces have to be sung in their original language, from memory, and in their original key.

In the final, one aria from Antonio Vivaldi's "Il Giustino" (a = hz 415 Vallotti) and a further obligatory piece from the competition list are to be presented (see repertoire list at [www.altemusik.at/cesti](http://www.altemusik.at/cesti)). The pieces have to be sung in their original language, from memory, and in their original key.

If no obligatory arias from Antonio Vivaldi's "Il Giustino" are listed for a voice category, one indicated obligatory aria from another opera by Vivaldi must be selected for the corresponding voice category instead.

It is possible to present obligatory arias of a different voice category than the one indicated in the registration.

**Art. 16:** The competition comprises three rounds: 1<sup>st</sup> round, 2<sup>nd</sup> round and final (public) followed by the awards ceremony.

1<sup>st</sup> round

All participants sing a prepared aria of their choice. Additionally, the jury can exercise their right to request a further named aria. The performance time is limited to five minutes. At the end of the first round, the participants selected for the second round will be announced.

2<sup>nd</sup> round

The participants sing two arias of their choice. The performance time is limited to ten minutes.

3<sup>rd</sup> final

The participants sing one aria from Vivaldi's "Il Giustino" and one further obligatory piece.

**Art. 17:** Each participant is to perform his or her program without interruption in all rounds. However, the jury reserves the right to prematurely discontinue the performance by the competitor in the first two rounds.

### Judging

**Art. 18:** Judging is carried out according to the principles and methods sanctioned and stipulated in the rules and regulations by the jury.

**Art. 19:** The judges' decisions are final.

**Art. 20:** Participants, who have had a pupil-teacher relationship with a member of the jury in the past two years, must notify the organizer of this. In this case, the relevant jury member is exempt from judging the participant. The same applies to familial relationships between a participant and a member of the jury.

### Prizes

**Art. 21:** All participants in the final receive a prize certificate. The prizes are in euro:

1 <sup>st</sup> prize	4,000 €
2 <sup>nd</sup> prize	3,000 €
3 <sup>rd</sup> prize	2,000 €
Young Artist award	1,500 €
Audience prize	1,000 €

The prizes are awarded on the same evening as the final. Each participant must accept his prize in person.

- Participation at the Festwochen Masterclass with Anna Bonitatibus
- Concert within the scope of the Resonanzen Wien

- Engagement at the Musikfestspiele Potsdam Sanssouci
- Concert or opera engagement with Il Gusto Barocco / Jörg Halubek
- Engagement within the "Academie Konzerte" at the Haus der Musik Innsbruck under the direction of Howard Arman

### Please note

**Art. 22:** The day before the final, the finalists have the chance to prepare themselves for the final by means of speech coaching, style coaching and musical rehearsals with the music director and the ensemble.

- Art. 23:** The competition organizer has the exclusive, unrestricted right to make sound recordings, films and photos of the competition events and of the concert given by the finalists, to broadcast such on the radio and on television, to record them and to publish the performances on the website and in other data networks without remunerating the participants and their répétiteurs. Upon registration for the competition, the competition organizer has the right to publish submitted data (name and age, photo, native country and nationality, voice category, competition program, repertoire, CV) on the web pages of the Innsbruck Festival ([www.altemusik.at](http://www.altemusik.at)).
- Art. 24:** The singers eliminated during the preliminary and intermediary rounds will be given the opportunity to discuss their performance with individual members of the jury.
- Art. 25:** The competitors are responsible for the costs of travel to and from the competition, accommodation and catering.
- Art. 26:** Participants who do not obey these determined rules can be disqualified from the competition.
- Art. 27:** Within the competition application arising and for the competition required personal data of the applicant / participant will be stored and processed by the Innsbruck Festival. It uses personal data resulting from the application only for the purposes of completing the competition or contractual belongings in case of an engagement for the Barockoper:Jung and for own advertising measures. As far as it is necessary for the processing of the competition, data will be submitted to third parties (in particular jury members), which were in a permissible manner entrusted by the Innsbruck Festival to take care of the competition or parts of it.
- Art. 28:** The participant is advised that certain areas of the Haus der Musik Innsbruck (inter alia Great Hall and Small Hall) are under video surveillance and that this house has an electronic door locking system or access system. With acceptance of a key card the participant agrees to the use and further to the application of the data to the extent required for the execution of the competition. The Tiroler Landestheater und Orchester GmbH Innsbruck as operator of the house will comply with the respective data protection provisions.
